

The FBI has said it is investigating Chinese economic espionage in nearly all of its 56 field offices in America, highlighting the depth of the threat to the US.

FBI Director Christopher Wray told this to members of the Senate select Committee on Intelligence during a Congressional hearing on worldwide threat assessment.

"I think China writ large is the most significant counterintelligence threat we face. We have economic espionage investigations, for example—that's just one piece of it—in virtually every one of our 56 field offices," Wray said.

Over 90 members of hard-line religious parities have been arrested from different parts of Pakistan's Punjab province for holding demonstrations against the Supreme Court's decision to reject a review plea against the acquittal of Christian woman Aasia Bibi in a blasphemy case.

Punjab Police spokesperson Nabila Ghazanfar said that most arrests have been made from Lahore, Gujranwala and Rawalpindi.

"Police have arrested more than 90 activists of different religious parties mostly Tehreek-i-Labbaik Pakistan (TLP) on Tuesday and Wednesday for creating law and order situation," Ghazanfar told PTI on Wednesday.
