दहरादून में दर्ज प्राथमिकी रद्द कर दी थी। इन पत्रकारों के खिलाफ देशद्रोह, धोखाधड़ी, जालसाजी और आपराधिक साजिश जैसे आरोपों में इस साल जुलाई में ये प्राथमिकी दर्ज की गयी थी। उच्च न्यायालय ने अपने फैसले में प्राथमिकी निरस्त करते हुये इन पत्रकारों की याचिका में प्रदेश के मुख्यमंत्री त्रिवेन्द्र सिंह रावत के खिलाफ लगाये गये भ्रष्टाचार के आरोपों की सीबीआई जांच का आदेश दिया था। हालांकि, दो दिन बाद 29 अक्टूबर को उच्चतम न्यायालय ने मुख्यमंत्री के खिलाफ सीबीआई जांच के आदेश को कठोर बताते हुये इस पर रोक लगा दी थी। न्यायालय ने टिप्पणी की थी कि मुख्यमंत्री को सुने बगैर ही यह आदेश पारित किया गया और इससे हर कोई चकित रह गया। अब उत्तराखंड सरकार ने उच्चतम न्यायालय में याचिका दायर कर इन पत्रकारों के खिलाफ प्राथमिकी निरस्त करने का उच्च न्यायालय का आदेश खारिज करने का अनुरोध किया है। इन पत्रकारों ने आरोप लगाया था कि 2016 में झारखंड के गौ सेवा आयोग के अध्यक्ष पद पर एक व्यक्ति की नियुक्ति का समर्थन करने के लिये राज्य के मुख्यमंत्री त्रिवेन्द्र सिंह रावत के रिश्तेदारों के खातों में धन अंतरित किया गया था। न्यायमूर्ति अशोक भूषण, न्यायमूर्ति आर सुभाष रेड्डी और न्यायमूर्ति एम आर शाह की पीठ ने वीडियो कांफ्रेंस के माध्यम से सुनवाई करते हुये राज्य सरकार की ओर से पेश वरिष्ठ अधिवक्ता मुकुल रोहतगी से कहा, हम अंतरिम आदेश के माध्यम से प्राथमिकी बहाल नहीं कर सकते।
