पुलिस ने गुरुवार को यहां जयपुर की मूर्तिकार कॉलोनी से गिरफ्तार किया है। पुलिस ने बताया कि आरोपी को अलवर ले जाया जा रहा है। इस मामले का पांचवां आरोपी नवल किशोर अब भी फरार है। पुलिस ने इस मामले में तीन आरोपियों धर्मेन्द्र यादव, परमजीत सिंह और नरेश को पहले ही गिरफ्तार कर चुकी है और उनके खिलाफ आरोप पत्र भी दाखिल किया जा चुका है। पिछले साल जुलाई में अलवर के रामगढ़ इलाके में गौवश तस्करी के संदेह में रकबर उर्फ अकबर को कुछ लोगों ने बुरी तरह पीटा था। 20 जुलाई की रात खान और उसके दोस्त असलम ने कथित तौर पर लाडपुरा गाँव से गायों को खरीदा था और उन्हें अलवर जिले में लालवंडी के पास एक जंगली इलाके से होते हुए हरियाणा ले जा रहे थे, जब आरोपियों ने उन पर हमला किया।

सहारनपुर, (भाषा)। उत्तर प्रदेश के सहारनपुर जिले में पत्रकार आशीष और उसके भाई आशुतोष की हत्या के मुख्य आरोपी महिपाल और उसके परिवार के साथ-साथ पुलिस ने उसके पिता के खिलाफ भी दो मुकदमे दर्ज किये हैं। महिपाल के पिता पर अपने लाइसेंसी हथियारों को गलत तरीके से दूसरे व्यक्ति को देने का आरोप है।
