# supply for T farmers

OMER FAROOQ ■ HYDERABAD

History was made Tuesday midnight as Telangana became the first State in the country to supply 24 hours free power to the farmers for irrigation of their fields.

Making a statement on the floor of Telangana Assembly on Wednesday, Chief Minister K Chandrasekhar Rao said that 23 lakh agriculture pump sets across the State were getting free electricity round the clock since last night.

"It had happened nowhere in the country before. This is good news to the farmers who faced power problems from decades together. The power utilities of the State will closely monitor the transmission and distribution network for 5 to 6 days and supply 24 hours uninterrupted power on permanent basis from coming Rabi season," the Chief Minister said.

In Telangana 25 per cent of power was being utilised by Agriculture pump sets, KCR added.

Within a few days of the formation of Telangana State in June

2014, the duration of free power supply to the farmers was increased from four to nine hours. In June this year, it was increased to 24 hours in three districts on experimental basis, he added.

The Chief Minister praised the officials of the power utilities for meeting the highest ever demand of 9,500 MW power recently by supplying 198 million units of power.

"I am happy to announce that the power corporations are ready to supply 11,000 MW demand that is going to reach due to 24 hours power for Agriculture sector in ensuing Rabi season", he said.

While the present phase of 24 hour supply on experimental basis will end in a week's time it will become a permanent feature from March-April next year.

Chief Minister recalled that at the time of the formation of the State there was severe power crisis in the State and people were facing untold problems due to power cuts of two to four hours in Hyderabad, 6 hours in other cities, and 9 hours in villages.

## चोटिल फिन एशेज दौरे से वाहर, कुरैन टीम में शामिल

इंग्लैंड, (एपी)। इंग्लैंड के तेज गेंदबाज स्टीवन फिन आस्ट्रेलिया में एशेज श्रृंखला में नहीं खेल पाएंगे क्योंकि मेडिकल स्कैन में उनके बायें घुटने में चोट का खुलासा हुआ है।

फिन टीम के आस्ट्रेलिया आने के बाद पिछले हफ्ते पर्य में अभ्यास के दौरान चोटिल हो गए थे और वह पहले ही इंग्लैंड के पहले दो अभ्यास मैचों से बाहर हो गए थे। इंग्लैंड के लिए टी20 और एकदिवसीय अंतरराष्ट्रीय क्रिकेट खेलने वाली टीम कुरैन को फिन के विकल्प के तौर पर टीम में शामिल किया गया है और वह बुधवार को आस्ट्रेलिया के लिए रवाना होंगे। तेज गेंदबाज फिन ने 36 टेस्ट में 125 विकेट चटकाने हैं लेकिन उन्होंने इसमें दो ही मैच आस्ट्रेलिया में खेले हैं।

वह भी 2010 में एशेज श्रृंखला शुरूआत 23 नवंबर को ब्रिसबेन में होगा। इंग्लैंड को दो और टेस्ट मैच खेलने हैं जिसमें बुधवार इंग्लैंड में शुरू हो रहा चांस मैच भी शामिल है जो कि गैरी ब्रॉड से खेला जाएगा।
