

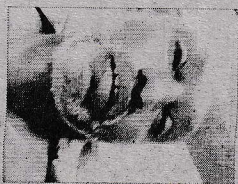

तमिलनाडु में डाक्टरों की हड़ताल समाप्त, मांगों पर विचार करेगी सरकार
चेन्नई, (थाण)। सरकारी डाक्टरों के महासंघ के आह्वान पर चार सूत्री मांगों को लेकर खिले एक हफ्ते से हड़ताल पर चल रहे तमिलनाडु के सरकारी डाक्टरों ने शुक्रवार को अपनी हड़ताल बापस ले ली। फेडरेशन आफ गवर्नमेंट डाक्टर एसोसिएशन ने कहा कि राज्य सरकार के इस आश्वासन पर उन्होंने अपनी हड़ताल बापस ले ली है कि वह उनकी मांगों पर विचार करेगी। इस हड़ताल से पूरे तमिलनाडु में बाल्य एवं आंतरिक विभाग के रोगी प्रभावित हुए। इससे शल्य चिकित्सा सेवा भी प्रभावित रही। फेडरेशन के एक प्रतिनिधि ने बताया, तमिलनाडु के मुख्यमंत्री के पत्नीसामी और स्वास्थ्य मंत्री सो. विजयभारकर ने आश्वासन दिया कि हमारी मांगों पर विचार किया जाएगा। हमने अपनी हड़ताल बापस ले ली। फेडरेशन ने कहा कि सरकार ने हड़ताली डाक्टरों के तबादलों एवं सेवा में ब्रेक जैसे कदम की घोषणा की थी, इन्हें रद्द किया जाना चाहिए। काम पर लौटने पर डाक्टरों को धन्यवाद देते हुए स्वास्थ्य मंत्री ने कहा, सेवा में ब्रेक का कदम बापस ले लिया गया है। अभी
