

हिस्से में उच्च गुणवत्ता वाली कोकीन की कथित आपूर्ति करने वाले केन्या के एक नागरिक को गिरफ्तार किया गया है। पुलिस ने शनिवार को बताया कि उसके पास से भारी मात्रा में मादक पदार्थ बरामद किया गया है, जिसका बाजार मूल्य तीन करोड़ रूपया है। मादक पदार्थ रोधी प्रकोष्ठ (एनसी) की बांद्रा इकाई ने शुक्रवार रात यह बरामदगी की। एक अधिकारी ने बताया, कार्टर रोड इलाके में एनसी की गश्त टीम ने एक व्यक्ति को रोककर उससे हरा थैला जब्त किया। जांच में उसके पास से तीन करोड़ छह हजार रुपये मूल्य की उच्च गुणवत्ता का आधा किलोग्राम से अधिक कोकीन बरामद हुई। व्यक्ति की पहचान केन्याई नागरिक डेविड लेमरॉन ओल तुबुलाई के तौर पर हुई। उन्होंने कहा, हमारी जांच में पता चला कि वह खार, जुहू और वासोंवा जैसे पॉश इलाकों में कोकीन के तस्करो में शामिल है। उसके खिलाफ एक मामला दर्ज किया गया है।

भोपाल, (वार्ता)। भारतीय जनता पार्टी महासचिव कैलाश विजयवर्गीय ने भोपाल संसदीय क्षेत्र से कांग्रेस प्रत्याशी दिग्विजय सिंह के 'देश में महात्मा गांधी के हत्यारे की विचारधारा की जीत' संबंधित बयान पर पलटवार करते हुए कहा कि लादेन को 'जी' और नाइक को 'शांतिदूत' कहने वालों की इस देश में हार तय है। श्री विजयवर्गीय ने अपने ट्वीट में कहा -
