Summary of proceedings of the Twenty- Ninth (29th) Annual General Meeting of Bharat Bhushan Finance & Commodity Brokers Limited

The 29th Annual General Meeting ("AGM") of the Members of Bharat Bhushan Finance & Commodity Brokers Limited ("the Company") was duly held on Wednesday, the 29th September, 2021 at 12.00 P.M. Indian Standard Time ("IST"), through video conferencing ("VC") / other audio visual means ("OAVM"), in compliance with the applicable provisions of the Companies Act, 2013 read with General Circular No.02/2021 dated January 13, 2021, General Circular no. 20/2020 dated May 05, 2020, General Circular no. 14/2020 dated April 08, 2020 and General Circular no. 17 /2020 dated April 13, 2020 issued by the Ministry of Corporate Affairs, Government of India, the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), and circular no. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated May 12, 2020 and circular no. SEBI/HO/CFD/CMD2/CIR/P/2021/11 dated January 15, 2021 issued by the Securities and Exchange Board of India.

The Company Secretary informed the members that Ministry of Corporate Affairs & Securities and Exchange Board of India ("SEBI") have permitted Companies to carry out AGM through Video Conferencing mode and other Audio-Visual modes.

Mr. Vijay Bhushan was elected as Chairman of the 29th AGM by the Directors present in the meeting. The Chairman ascertained the quorum and called the meeting to order. He welcomed the members participating in the AGM through VC/ OAVM.

Mr. Kuldeep Kumar Gupta, Chairman of the Audit Committee was present at the AGM to answer the shareholder's query. Mr. Varun Saihgal Chairman of the Nomination and Remuneration Committee and Mrs. Nisha Ahuja, Chairperson of the Stakeholders Relationship Committee was also present at the AGM. Ms. Madhvi Ahuja and Mr. Madhav Bharat Bhushan, Directors of the Company were also present in the meeting.

The Chairman of AGM introduced the Directors present, Chief Financial Officer and Company Secretary of the Company. Mr. G C Agarwal, Proprietor of M/s G C Agarwal & Associates, Auditors and Ms. Kavita Pamnani, Proprietor of Kavita Pamnani & Associates, Secretarial Auditor of the Company and scrutinizer for the meeting, have also attended the Company AGM.

The Chairman drew the attention of members to the registers/ other documents available for inspection by the members electronically.

The Chairman addressed the members and apprised them about the challenges posed by $Q \star P^{V}$ COVID-19 pandemic and performance of the Company.

It was informed to the Members that pursuant to the provisions of Companies Act, 2013 and rules made thereunder read with Listing Regulations and Secretarial Standard on General Meetings issued by the Institute of Company Secretaries of India (ICSI), members of the Company were provided Electronic Voting Facility ("remote e-voting") which commenced on Sunday, 26th September, 2021 (9:00 A.M. IST) and ended on Tuesday, 28th September, 2021 (5:00 P.M. IST). The facility of E-voting at AGM was also made available

for those members who participated in the AGM through VC/ OAVM and did not cast their vote(s) by remote E-voting.

Further, following items as stated in the Notice of the 29th AGM, were transacted at the AGM:

Ordinary Business:

- 1. To receive, consider and adopt the Audited Financial Statements of the Company for the financial year 2020-21 including Audited Balance Sheet as at 31st March, 2021, the Statement of Profit and Loss and Cash Flow Statement for the year ended on that date together with the Reports of the Board of Directors and Auditors thereon. (Ordinary Resolution)
- 2. To declare dividend on Equity Shares for the Financial Year ended 31st March, 2021. **(Ordinary Resolution)**
- 3. To appoint a Director in place of Ms. Madhvi Ahuja (DIN:00001869), who retires from the office by rotation in terms of Section 152 (6) of the Companies Act, 2013 and being eligible, offers herself for re-appointment. (Ordinary Resolution)

Special Business:

4. Appointment of Mr. Madhav Bharat Bhushan (DIN: 08213574) as a Director (Ordinary Resolution)

The Company Secretary informed that Ms. Kavita Pamnani, Practicing Company Secretary in whole time practice was appointed by the Board of Directors of the Company, to scrutinize the remote E- voting and voting in the AGM. E-voting at AGM was also made available for those members who participated in the AGM through VC/ OAVM and did not cast their vote(s) through remote E-voting. The consolidated results (for remote e-voting and E-voting in the AGM) of the 29th AGM would be made available together with the scrutinizer's report at the website of the Company and National Securities Depository Limited ("NSDL") within 48 Hours of conclusion of the AGM.
