एवं पड़ोसी जिलों में एच।एन। विषाणु के प्रसार पर रोक के तमाम प्रयासों के बावजूद स्वाइन फ्लू से प्रभावित चार और लोगों को यहां के सरकारी अस्पतालों में उपचार के लिये भर्ती कराया गया। अस्पताल सूत्रों ने बताया कि छह लोगों का पहले से ही अस्पताल में उपचार चल रहा है, लेकिन बीती शाम को दो महिलाओं समेत चार लोगों को उपचार के लिये भर्ती कराया गया। उन्होंने बताया कि सभी चारों मरीजों में एच।एन। विषाणु की पुष्टि हुई है और उन्हें विशेष वार्ड में रखा गया है। उन्होंने बताया कि बहरहाल निजी अस्पतालों में उपचार करा रहे लोगों का आंकड़ा ज्ञात नहीं है। बीते 10 दिनों के दौरान इस बीमारी के चलते चार लोगों की मौत हुई है। मरने वालों में सलेम से एक वर्षीय एक बच्चा भी शामिल है। बच्चे का उपचार यहां के निजी अस्पताल में चल रहा था। इन घटनाओं के कारण जिला अधिकारियों को इसकी रोकथाम के लिये प्रयासों में तेजी लाना पड़ा।

श्रीनगर, (भाषा)। जम्मू कश्मीर में कुछ जगहों पर भूस्खलन के मददेनजर आज लगातार दूसरे दिन श्रीनगर-जम्मू राष्ट्रीय राजमार्ग यातायात के लिये बंद रहा। वहीं, कश्मीर में शुष्क मौसम और अधिकतर स्थानों पर रात का तापमान जमाव बिंदु के आसपास रहा। कुछ स्थानों पर भूस्खलन के चलते सड़क पर जमा हुए मलबे के कारण आज लगातार दूसरे दिन भी श्रीनगर-जम्मू राजमार्ग बंद रहा। उन्होंने कहा कि रामबन और बटटेरी चरमा के निकट भूस्खलन हुआ है जिसके चलते राजमार्ग बंद करना पड़ा। अधिकारी ने बताया कि करीब 300 किलोमीटर लंबे राजमार्ग के पास कई वाहन फंसे हुए हैं और मलबा हटाये जाने के बाद ही उन्हें आगे जाने की अनुमति होगी। अधिकारी ने बताया कि कर्मचारी और मशीनरी की मदद से मलबा हटाने का काम चल रहा है, जिसके बाद मौसम की स्थितियों को देखते हुए वहां फंसे वाहनों को आगे जाने की अनुमति होगी।
